# I. NOTICE

**NOTICE IS HEREBY GIVEN** that the PORT OF BREMERTON is hereby seeking proposals for the removal of sludge from the LOSS system. The total estimated cost shall not exceed \$50,000.

**SCOPE AND NATURE OF WORK**: The Contractor shall furnish all labor, materials, equipment, permits, transportation, and incidentals necessary to remove accumulated sludge from the Lagoon of a Large On-Site Sewage System (LOSS). The system is located at Constance Drive SW, Olympic View Industrial Park, Bremerton, WA.

**PROPOSAL SUBMITTAL INFORMATION AND SITE VISIT:** Submit proposals by 3:00 PM (PDT) July 14, 2025, to: Port of Bremerton, Attn: Ellen Ataie, Contract Administrator, 8850 SW State Hwy 3, Bremerton, WA 98312. E-mailed proposals area also accepted to <u>ellena@portofbremerton.org</u> with cc to <u>arneb@portofbremerton.org</u>. Request a delivery and read receipt. A public bid opening will not be held.

**CONTRACT ISSUES:** This work is considered purchased services under chapter RCW 39.26. The successful \contractor will be required to execute a Purchase Order with the Port. Among other requirements, Port contracts are subject to the following:

A. Prevailing Wage Provision: The workers of all contractors and subcontractors on all Port "public works" as defined by RCW 39.04.010, shall be paid the "prevailing rate of wage" including "usual benefits" and overtime, paid in the locality as those terms are defined by Chapter 39.12 RCW. The contractor is responsible for obtaining and completing all required government forms and submitting same to the proper authorities. In accordance with RCW 39.12.030. applicable prevailing wage rates can be found online at https://lni.wa.gov/licensing-permits/public-works-projects/prevailing-wage-rates/.

B. Insurance. Contractor agrees to obtain at its own cost and expense, public liability insurance with combined bodily injury and property damage limits in the amount of \$1,000,000 in a form satisfactory to the Port of Bremerton, naming the Port as an additional insured. Such insurance shall not be diminished or rescinded without first giving the Port thirty (30) days written notice.

**BIDDER RESPONSIBILITY CRITERIA** The contract will be awarded to the party submitting the "lowest responsible proposal," subject to any products and/or vendor preferences provided by applicable Washington State laws, taking into consideration the quality of the articles proposed to be supplied, their conformity with specifications, and the purposes for which required. The Port may reject any and all proposals.

In determining "lowest responsible proposal," in addition to price and other factors outlined above, the following criteria are used in determining the lowest responsible proposal:

- 1. At the time of bid submittal, have a certificate of registration in compliance with chapter 18.27 RCW;
- 2. Have a current state unified business identifier number;
- 3. If applicable, have industrial insurance coverage for the bidder's employees working in Washington as required in Title 51 RCW; an employment security department number as required in Title 50 RCW; and a state excise tax registration number as required in Title 82 RCW;

- 4. Not be disqualified from bidding on any public works contract under RCW 39.06.010 or 39.12.065(3);
- 5. Have completed or be exempt from the L&I required public works training per 39.04.350 and RCW 39.06.020,
- 6. Within the three-year period immediately preceding the date of the bid solicitation, not have been determined by a final and binding citation and notice of assessment issued by the department of labor and industries or through a civil judgment entered by a court of limited or general jurisdiction to have willfully violated, as defined in RCW 49.48.082, any provision of chapter 49.46, 49.48, or 49.52 RCW.

#### SUPPLEMENTAL BIDDER RESPONSIBILITY CRITERIA

- 1. Satisfactory completion of projects of similar size or scope within the past three years.
- 2. Availability of contractor to complete the work within the required schedule.
- 3. Quality and timely performance on any previous contracts with the Port of Bremerton.

If a bidder is determined to be non-responsive, the bidder will be notified by the Port in writing (electronically) as to the deficient criteria and allowed two working days to appeal the Port's determination in writing. Failure to properly complete this form may be cause for rejection of proposal.

# Sludge Removal – LOSS Sewer Lagoon

#### 1. Project Overview

**Project Title:** Sludge Removal – LOSS Sewer Lagoon

#### 2. Scope of Work

The Contractor shall furnish all labor, materials, equipment, permits, transportation, and incidentals necessary to remove accumulated sludge from the Lagoon of a Large On-Site Sewage System (LOSS).

The work shall include:

- Dewatering and removal of lagoon sludge.
- Safe transport and disposal at a permitted facility.
- Compliance with environmental and regulatory standards.
- Providing manifests and records for all loads removed.

# 3. Project Budget and Inclusions

- Total Contract Price: Not to exceed \$50,000
- Includes: All labor, equipment, transport, disposal fees, and applicable Kitsap County sales tax (9.2%)
- **Contract Price Must Cover:** Estimated sludge removal volume within this budget.

#### 4. Estimated Volume & Load Requirements

- The Contractor shall estimate the **maximum number of gallons** of sludge that can be removed within the \$50,000 budget.
- Bidders must provide an estimated **gallons per load** and **number of loads** proposed.
- Removal shall occur over a **12-week period**.
- Contractor may remove a maximum of 1–2 loads per week.

Bids will be evaluated on efficiency and cost per gallon removed within the total budget.

#### 5. Project Timeline

- Expected Notice to Proceed (NTP): July 18, 2025
- Start of Removal: Within 14 calendar days of NTP
- Duration: 12 weeks from NTP
- **Completion Deadline:** October 13, 2025

### 6. Proposal Contents

- Completed proposal form.
- Proposed gallons to be removed within budget.
- Load size and load-out schedule.
- Contractor qualifications and prior experience.
- Disposal facility information (including permit number).
- Equipment list.
- Safety and environmental compliance plan.
- A bid bond is not required.

#### 7. Permits and Compliance

The Contractor is responsible for:

- Acquiring and complying with all local, state, and federal permits.
- Ensuring environmental protection throughout removal and transport.
- Keeping accurate records of all removed sludge, including manifests.
- Proper disposal at a permitted facility.
